## This in from the MAS Support Team

There appears to be an issue with email recipients being able to receive reports from the rebranded reports sender of [NoReply@securitas.com](mailto:NoReply@securitas.com).

Reports coming out of Mastermind and MASweb are both coming from the same sender, so both instances of reports are not being received. The reports are being blocked and are not even being sent to the recipients junk/spam folders.

This is not on our end. The recipients will need to go into their email settings and add [NoReply@securitas.com](mailto:NoReply@securitas.com) as a Safe Sender. If this does not solve the problem the recipients will need to contact their email provider to have add [NoReply@securitas.com](mailto:NoReply@securitas.com) as a Safe Sender.
