Alarm, security, and elevator services and equipment currently located in the 602 and 623 area codes and programmed to dial only seven digits must be updated or reprogrammed to dial area code + telephone number for all calls in the 602 and 623 area codes. Reprogramming of alarm equipment should be completed by February 11, 2023.
