Area Code Boundary Elimination Overlay

To ensure a continuing supply of telephone numbers, the Arizona Corporation Commission approved the elimination of area code boundaries between the 480, 602 and 623 area codes in the Phoenix metro area. As a result of the overlay, a new local dialing procedure requires callers to dial area code + telephone number. Alarm, security, and elevator services and equipment currently located in the 602 and 623 area codes and programmed to dial only seven digits must be updated or reprogrammed to dial area code + telephone number for all calls in the 602 and 623 area codes.

Reprogramming of alarm equipment should be completed by February 11, 2023.

Alarm Validation Standards

ANSI has validated the TMA-AVS-01 Alarm Validation Standards. The Standards identify the following alarm levels:

- Alarm Level 0 No Call for Service
- Alarm Level 1 Call for Service with limited to no additional information
- Alarm Level 2 Call for Service with confirmed or 'highly probably' human presence with unknown intent
- Alarm Level 3 Call for Service with confirmed threat to property
- Alarm Level 4 Call for Service with confirmed threat to life


